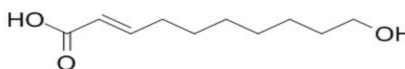

BIOLOGICAL ACTIVITY OR INHIBITORS

Phillygenin, isolated from the EtOAC extract of Forsythia suspense, has a high hypolipidemic activity and this activity may be attributed to its antioxidant potential. [1]

Phillygenin has a protective effect on acute liver injury induced by CC14 in rats, this might be associated with increasing antioxidant capacity, decreasing lipid peroxidation in liver tissue and reducing TNF- α and IL-8 levels. [2]

(+)-Phillygenin, phillyrin, and (-)-phillygenin exert the strongest inhibitory activities on nitric oxide (NO) production in lipopolysaccharide-stimulated macrophage RAW 264.7 cells with IC₅₀ values of 25.5, 18.9, and 25.5 μ M, respectively, these compounds may prove beneficial in the development of natural agents for prevention and treatment [3]

Phillygenin reveals cytotoxic effects on four human tumor cell lines (A549, SK-OV-3, SK-MEL-2, and HCT15) at concentrations below 30 μ g/mL. [4]

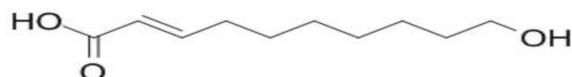
