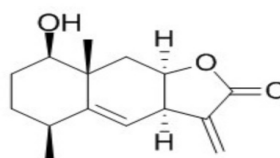

BIOLOGICAL ACTIVITY OR INHIBITORS

1beta-Hydroxyalantolactone can modulate many processes that influence inflammatory reactions, it has protective effects against atopic dermatitis-like skin inflammation. [1]

1beta-Hydroxyalantolactone exhibits remarkable cytotoxicity against HEP2, SGC-7901 and HCT116 human cancer cell lines, comparable with etoposide (Vp-16) used as reference drug, furthermore, treatment of HEP2 cells with 1beta-hydroxyalantolactone induces apoptosis associated with cleaved procaspase-3 and PARP. [2]

1beta-Hydroxyalantolactone has protective effects on cerebral ischemia-reperfusion injury, the mechanism is associated with reducing the level of extracellular Prx1 and Prx5, inflammatory cytokines(IL-1 β , TNF- α , IFN- γ and IL-6), adhesion molecule (ICAM-1) and matrix metalloproteinase (MMP-9). 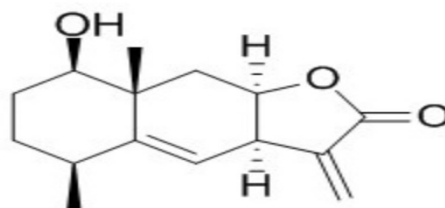
