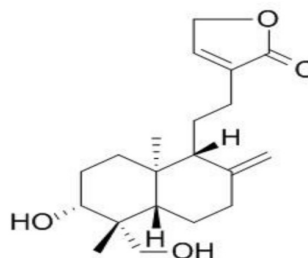

BIOLOGICAL ACTIVITY OR INHIBITORS

14-Deoxyandrographolide has calcium channel blocking activity, it is an effective antagonist of PAF-mediated processes in bovine neutrophils, probably by virtue [1]
14-Deoxyandrographolide has hepatoprotective efficacy desensitizes hepatocytes [2]
14-Deoxyandrographolide has inhibitory effects on nitric oxide production in lipopolysaccharide-activated macrophages.[3]
14-Deoxyandrographolide has cardioprotective activities, it can up-regulate cellular-reduced glutathione level and protects cardiomyocytes against hypoxia/reoxygenation injury [4]
14-Deoxyandrographolide shows anticancer activity on diverse cancer cells representing different types of human cancers, it shows enhanced proliferation and interleukin-2 (IL-2) [5]
14-Deoxyandrographolide is an antifungal compound, it could be used for the treatment of fungal skin infections. [6]
14-Deoxyandrographolide has vasorelaxant effect, which is more active in the calcium independent pathway and more sensitive in the initial stage of contraction. [7]
