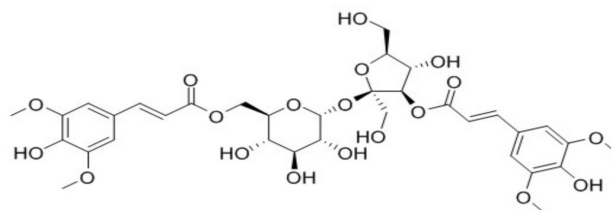

BIOLOGICAL ACTIVITY OR INHIBITORS

3,6'-Disinapoyl sucrose(DISS), an oligosaccharide ester natural product originating from the root of wild *Polygala tenuifolia*, has neuroprotective effects against glutamate toxicity by the downregulation of proapoptotic gene Bax and the upregulation of antiapoptotic gene Bcl-2, it has neuroprotective effects through increased brain-derived neurotrophic factor (BDNF) levels and cyclic AMP response element (CRE)-binding protein (CREB) phosphorylation via the CaMKII and ERK1/2 pathway, which might be of importance and contribute to its clinical efficacy for the treatment of neurodegenerative diseases. 3,6'-Disinapoyl sucrose has antidepressant effects on hippocampal neuronal plasticity and neurotrophic signal pathway in chronically mild stressed rats, which are mediated via measuring monoamine oxidase (MAO), the hypothalamic-pituitary-adrenal (HPA) axis and oxidative systems. [3]

3,6'-Disinapoyl sucrose has the protective effect on increasing proliferation of hippocampus neural progenitor cells, the antidepressant-like effects of DISS and its mechanisms might be involved by up-regulation of the progenitor cell proliferation

3,6'-Disinapoyl sucrose has antioxidant activity. [6]

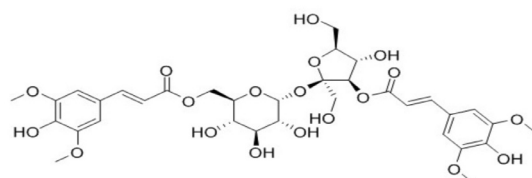
